Important Notes:

1. One mill equals \$1.00 in tax for each \$1,000.00 in Taxable Value (TV)
2. Summer taxes are due by August 31, 2010 without penalty. A 4% penalty is applied on September 1, 2010 and a 1/2% per month thereafter to 6%
3. Billed and collected by the City of Madison Heights.
4. Schools collect 50% in Summer and 50% in Winter.
5. Winter taxes are due by February 14, 2011 without penalty. A 3% penalty will be applied thereafter.
6. After March 1, 2011 all taxes are payable at the office of the Oakland County Treasurer with additional penalties and interest
