Important Notes:

- 1. One mill equals \$1.00 in tax for each \$1,000.00 in Taxable Value (TV)**
- 2. Summer taxes are due by August 31, 2015, without penalty. A 4% penalty is applied on September 1, 2015 and a 1/2% per month thereafter to 6%**
- 3. Billed and collected by the City of Madison Heights.**
- 4. Schools collect 50% in Summer and 50% in Winter.**
- 5. Winter taxes are due by February 16, 2016, without penalty. A 3% penalty will be applied thereafter.**
- 6. March 1, 2016, and after, all taxes are payable at the office of the Oakland County Treasurer with additional penalties and interest**
