### Winter Property Taxes are payable December 1, 2025 to February 17, 2026 without penalty.

Starting February 18, 2026 a 3% penalty is calculated on tax due.

Beginning March 3, 2026 delinquent bills must be paid to Oakland County Treasurer.

### IMPORTANT INFORMATION

<b>Your cancelled check is your receipt.</b>	<b>POSTMARK IS NOT ACCEPTED AS BEING ON TIME.</b> Allow at least 5 business days for first class postal delivery.
<b>Check Policy:</b> Checks are accepted only as conditional payment. If check is not honored by bank, tax is unpaid and subject to penalties and fees. A fee is assessed each time a check is returned unpaid.	<b>Errors and Omissions:</b> Examine your statement closely for corrections. If your principal residence exemption percentage is incorrect, contact City Assessor at (248) 837-2644 to inquire about your appeal rights.
If your taxes are paid by a mortgage company and you do not see a mortgage code, forward this bill to your mortgage company.	<b>Review Carefully</b> <ul style="list-style-type: none"><li>• Legal responsibility for paying on the correct parcel of property rests with the taxpayer.</li><li>• Treasurer is not allowed to waive penalty.</li></ul>
<b>FAILURE TO RECEIVE THE TAX BILL DOES NOT WAIVE PENALTY OR INTEREST.</b>	
<b>DELINQUENT BILLS:</b> Beginning March 3, 2026, delinquent bills must be paid to Oakland County Treasurer, including penalties and fees. During the month of March, a revised statement from the City Treasurer must accompany your remittance to the County Treasurer. Mail or deliver payment to: Oakland County Treasurer, <b>1200 N. Telegraph, Dept. 479, Pontiac, MI 48341-0479.</b> <b>24-HOUR TAX HOTLINE (248) 858-0025 or (888) 600-3773:</b> (real property only, not for personal property) Delinquent property tax information is available by calling the Oakland County 24 Hour Tax Hotline, enter your 10-digit parcel number (begins with 25). There is no charge for this service.
