The City of Madison Heights is offering a limited financial assistance grant for its residents who are experiencing financial hardship. Participants will be eligible for either a 25% or 50% grant based on household income and are entitled to receive up to two per year (July 1 – June 30) per child and must apply prior to the program starting.

- Grants will be available on a first come, first served basis up to the maximum per program.
- Please allow 5 working days for the department to process application, which must be received on or before program registration.
