**Summer Property Taxes are payable July 1, 2019 to September 3, 2019 without penalty.**  
 Starting September 4, 2019, a 4% penalty is applied and ½ % added each month thereafter.

### IMPORTANT INFORMATION

Your cancelled check is your receipt.

If your taxes are paid by a mortgage company and you do not see a mortgage code, forward this bill to your mortgage company.

**FAILURE TO RECEIVE THE TAX BILL DOES NOT WAIVE PENALTY OR INTEREST.**

**Check Policy:** Checks are accepted only as conditional payment. If check is not honored by bank, tax is unpaid and subject to penalties and fees. A fee is assessed each time a check is returned unpaid.

**Errors and Omissions:** Examine your statement closely for corrections. If your principal residence exemption percentage is incorrect, contact Oakland County Equalization at (248) 858-0776 to inquire about your appeal rights. Return this bill to the City of Madison Heights if you no longer own this property.

**POSTMARK IS NOT ACCEPTED AS BEING ON TIME.** Allow at least 5 business days for first class postal delivery.

**Deferment of Summer Taxes:** If your gross income did not exceed \$40,000 for the preceding calendar year and you meet other Michigan Department of Treasury deferment requirements, you may be eligible to apply to defer the due date of your summer taxes without penalty or interest charges until February 14, 2020. An annual deferment form **must** be completed, signed and submitted to the City of Madison Heights on or before September 17, 2019.

 Property tax information is available by calling the **Oakland County 24 Hour Tax Hotline**, enter your 10-digit parcel number (begins with 25). There is no charge for this service.
