

407. Ordinance 1013- Final Reading.

Motion by Councilman McGillivray, supported by Councilwoman Scott, to adopt Ordinance 1013 on second and final reading, as follows:

ORDINANCE 1013

AN ORDINANCE TO AMEND ORDINANCE 571,
BEING AN ORDINANCE CODIFYING AND
ADOPTING A NEW CODE OF ORDINANCES FOR
THE CITY OF MADISON HEIGHTS BY AMENDING
IN PART CHAPTER 2, ARTICLE XIV, SECTION 2-294
TO PROVIDE THAT ONE MEMBER OF THE
MADISON HEIGHTS HISTORICAL COMMISSION
SHALL BE A CITY COUNCIL MEMBER.

THE CITY OF MADISON HEIGHTS ORDAINS:

SECTION 1. That Chapter 2, Article XIV, Section 2-294 of the City of Madison Heights Code of Ordinances is amended to read as follows:

Sec. 2-294. Composition; appointments; compensation

The Madison Heights Historical Commission shall consist of 16 members. 1 member of the Commission shall be a city council member. 14 members, appointed by the city council, will serve without compensation. The city librarian will hold a permanent position on the commission, subject to the other provisions of this Article.

SECTION 2. This ordinance supersedes all ordinances or parts of ordinances in conflict with this ordinance, but only to the extent necessary to give this ordinance full force and effect.

SECTION 3. Should any section, subdivision, clause, or phrase of this ordinance be declared by the courts to be invalid, the validity of the ordinance as a whole, or in part, shall not be affected other than the part invalidated.

SECTION 4. All proceedings pending and all rights and liabilities existing, acquired or incurred at the time this ordinance takes effect, are saved and may be consummated according to the law in force when they were commenced.

SECTION 5. This ordinance as ordered shall take effect Ten (10) days after its adoption and upon publication.

SECTION 6. A copy of this ordinance may be inspected or purchased at the City Clerk's office between the hours of 8:00 A.M. and 4:30 P.M. on regular business days.
